You have filed or you have been served with an action for child custody (or a motion to modify the current child custody order in Orange and Chatham County, North Carolina¹), and you know mediation is the next step, what now?

Mandatory Custody Mediation Process

You may need to check your spam folder for that email. 

STEP 4D: If Changes Need to be Made

In general, changes can still be made to items negotiated in Mediation. If you receive the Parenting Agreement and would like to make some changes, follow these steps within 10 days:
□ Do not sign or return your Signature Page.
\Box State the line number (if you do not see these, simply put the paragraph or section number of the draft).
\square Make a note proposing how you believe the line should be rewritten.
\square Email this suggestion (both section number and rewritten statement) to both the Mediator AND your co-parent.

Helpful Notes:

- Failure to do any of the above steps may result in delays.
- If either party chooses not to sign, does not agree to follow suggested changes, does not respond by the deadline (10 days), the Mediation will close, and the case will be released from Custody Mediation. **See 4C.**
- Routinely check Spam/Junk folders. Emails for Mediators may end up here.
